The Sweepstakes is subject to these Official Rules, and by entering, all participants agree to be bound by the terms and conditions herein. The Sweepstakes is open to legal residents of the United States who have reached the age of 18 years. Sponsor’s employees, officers, directors, and their immediate family members are ineligible; and employees, officers, directors, and their immediate family members of affiliates are ineligible. No purchase, contribution, donation, or payment is required. Making a purchase, contribution, donation, or payment will not increase your chances of winning. There is a limit of one entry request per outer envelope. One ticket will be returned in the envelope provided to each mail-in request that complies with these requirements. All entries must be received by 11:59 PM EST on Sunday, December 19, 2021. All requests for entry must be postmarked no later than by 11:59 PM EST on Sunday, December 19, 2021. Mail for free entry method to any other address will be disqualified and destroyed. There is a limit of 5 entries per person, regardless of method of entry. All proceeds of the Sweepstakes will benefit the American Kennel Club’s Political Action Committee. The drawing will be conducted at Monday, January 3, 2022, in the AKC Corporate Offices, located at 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617. The American Kennel Club’s Vice President of Government Relations will conduct the drawing. One ticket will be drawn to determine the winner of the Grand Prize. The odds of winning depend on the number of entries received. No more than 1,000

tickets will be sold. The winner need not be present to win. The winner will be notified by Wednesday, January 5, 2022, by telephone call, or alternatively by email. If the prize not claimed within fourteen (14) days, an alternate winner will be selected. The final winner will be announced to the public in the edition of the Taking Command online newsletter first published following the date of the drawing. One (1) Grand Prize will be awarded. The Grand Prize consists solely of one gift certificate for an Impact dog travel crate. The retail value of the Grand Prize is \$850. Sponsor reserves the right to substitute the prize, or any portion thereof, for any reason. Taxes and any other charges on the Grand Prize are the responsibility of the prize winners.
